Cancellation Policy: *Given the uncertainties caused by the COVID-19 pandemic, a Sponsor or an Exhibitor will be given a full refund by AGCMO if the scheduled event is canceled or if the Sponsor/Exhibitor must cancel their participation for COVID-19 related reasons at any time prior to the Scheduled Event.

Non-COVID-19 Related Cancellation

* With notice of 3 months or more prior to conference date, AGC of MO will reimburse 75% of the total cost of sponsor/ exhibitor charge.

* Notice given between 2 and 3 months prior to conference date, AGC of MO will reimburse 50% of the total cost of sponsor/ exhibitor charge.

* Notice given between 1 and 2 months prior to conference date, AGC of MO will reimburse 25% of the total cost of sponsor/ exhibitor charge.

* No reimbursement if notice is less than 1 month to the conference date.

* This policy applies regardless of whether the sponsor/exhibitor fee is paid prior to the conference or invoiced after.
